Sanders Co. are not paid when due. For purposes of any legal action that may be initiated, the customer consents to the jurisdiction of Colorado and its Courts and, including the county of Jefferson or the county where any branch of GTS is located which supplied the customer.
- The laws of Colorado will govern any transaction between GTS and the customer.
- All returned goods must be returned with an invoice number and the date purchased within 30 days of purchase. All special orders of non-stock items will be subject to a factory restock charge. All special order returned goods require written approval from the George T. Sanders Co. and authorization from the supplier is required for all returns prior to issuing credit to the purchaser.
- The terms of the Dealer Release and Disclaimer of Warranties form shall apply to any order or sale.
- The customer has a fiduciary responsibility under the trust fund provisions of both Colorado's mechanics' lien statutes and its public works statutes.
- All dates of delivery are approximate and not guaranteed. Absolute confirmed dates of delivery must be agreed to in writing. All delivered material must be checked for physical damage and reported within 3 days.
